APPLICATIONS:

- There is **NO FEE** to enter the Riverton Town Days Parade, but parade entries are limited to the first 100 entries. No entries will be taken after the parade is full, please submit your application early.
- **All applicants will receive a confirmation packet sometime after June 8 and before June 24.** This packet will include your parade number, map of parade route, line-up & check-in details, etc. Please ensure you put the name & address you would like this packet sent to on your application. Please note: If the parade is full or your application is denied we will notify you ASAP.
- **Waiver and Release of Damages:** Enclosed are several Waiver and Release of Damage Forms. These forms must be filled out by every participant that will be driving, riding or walking with your entry. Please turn these in with your application. No exceptions. Please make copies as needed.
- Absolutely no applications will be taken after the deadline date.
- There will be no Judging or Awards.
- Riverton City reserves the right to deny an application if we determine an entry to be controversial, unlawful, or otherwise considered to be inconsistent with the standards or the purpose of the Riverton City Town Days Parade.

RESTRICTIONS AND CONCERNS

- **Dance, Drill and Marching Bands** should design routines that permit **constant forward movement** following their entry.
- **Candy:** participants are allowed to throw candy, but please follow these guidelines: 1) Candy should be individually wrapped. 2) We recommend participants who are throwing candy walk along side the street to ensure the candy is thrown into the crowd, not into the street. 3) If participants are throwing from a vehicle, please ensure they are throwing the candy far enough away from the vehicle that children aren't at risk by having to come too close to vehicle to pick it up.
- **ATV's, Motorcycles, Golf Carts:** Participants are welcome to include ATV's, motorcycles, golf carts with their entries, but please note: 1) participants must obey all laws and regulations regarding motorized vehicles, failure to do so could result in a citation from local law enforcement and denial of any future parade applications. 2) We recommend participants wear proper safety gear. **3) Riverton City reserves the right to deny any entry we determine to be unsafe.**
- **Water guns and water balloons are prohibited.**
