Category I - Riverton City use

Category II - Volunteer Organizations formally recognized by Riverton City.

Category III - Other tax-supported agencies and community service organizations charging no fee or a minimal fee (4H, American Red Cross, etc.) for single use such as town meetings, blood drives, etc.

Category IV - Non-Commercial Resident: owns, resides or rents on a continual basis within the Riverton City limits. Residents must show proof of residency (water bill, phone bill, etc.). Includes charitable organizations charging a fee.

Category V - Non-Commercial Non-Resident: All other persons not meeting the requirements of a resident. Includes charitable organizations charging a fee.

Category VI - Commercial Resident: Any Riverton business who reserves a facility with the intent to sell a product, service, etc. during their reservation.

Residents must show proof of residency (water bill, phone bill, etc.).

Category VII - Commercial Non-Resident: Any non-Riverton business who reserves a facility with the intent to sell a product, service, etc. during their reservation.
